#### REGULATIONS FOR UNDERGRADUATE DEGREE COURSES

# CBCS PATTERN with effect from 2017-2018 onwards

#### **Definitions:**

- a) Programme A course of study leading to the award of a degree in a discipline. (E.g.: B.Sc\B.Com)
- b) Branch Discipline of study (e.g.: B.Sc computer science)
- c) Curriculum The various courses (subjects / paper) a student must study in a particular branch.
- d) Course The theory & practical subject OFFERED under the curriculum.
- e) Credit A unit of measurement based on the duration of the contact hours, Content and quality of the subject matter.
- UG Curriculum: The UG Curriculum under the CBCS consists of five parts and the medium
  of instruction is English. Part six provides additional credits with Value added courses and
  Inter Department Learning Papers.
- 2. Eligibility for Admission to the Course: Candidate for admission to the first year of the UG degree programme shall be required to have passed the higher secondary examination (Academic or Vocational) conducted by the Govt. of Tamil Nadu in the relevant subjects or other examinations accepted as equivalent thereto by the parent university, subject to such other conditions as may be prescribed there for.

- **3. Duration of the Programme:** The UG programme will comprise six semesters with two semesters per academic year, extending over a total duration of three years. Examination shall be conducted at the end of every semester for the respective subjects. Each semester has 75 instructional days consists of 6 teaching hours per working day. Thus, each semester has 450 teaching hours and the whole programme has 2700 teaching hours.
- **4.** Choice Based Credit System (CBCS): All Undergraduate Programmes offered by the College shall be under Choice Based Credit System (CBCS). Choice based credit system is introduced with the aim of offering flexibility in the choice of courses to the students.

# **Objectives of the Choice Based Credit System:**

- To facilitate the students to have greater flexibility in their choice of courses.
- To widen the spectrum of knowledge of students by means of Core, Allied, Project / Electives, Value Education, Ability Enhancement Compulsory Course and Skill Enhancement Courses.
- To revamp the curriculum, to impart entrepreneurial skills and placement potential quality.
- To incorporate need based knowledge in tune with the location and neighborhood of the institution.
- To allocate credit points to each paper of the study based on the weight age of the contact hours, content and quality.
- To extend opportunities to fast learners in order to earn additional credit from advanced learners courses as well as value added courses.
- To maintain the total credit points of each programme on par with international standards.
- To assess the performance of students in terms of marks & credit points
- Each department will offer not less than 3 papers under additional credit system. The papers are job oriented.
- The respective department will offer guidance outside the working hours. Students can choose any course from III semester onwards.

- 5. **Course of Study:** The course of study for the UG degree courses of all branches shall consist of the following
- **5.1 Part I**: Language: Tamil or any one of the modern/classical languages i.e. Malayalam, French and Hindi.

It is absolutely obligatory for all the UG students to study a language under part I. A student can select and study any one of the languages offered under part I. The syllabus drafted would enable the students, to communicate with the ease and effectiveness in that language. It shall be offered in the **first two semesters** with one examination at the end of each semester.

# **5.2. Part II**: Language: English

The study of English has been made mandatory for all UG students under part II. English being the window to the outer world in the context of the globalization scenario the contents of the syllabus is tailored in a fashion suitable for imparting the classical and the modern facets of the language and literature, besides conferring a mastery of fluency and command over the language, providing a clout to compete for employment opportunities. The subject shall be offered during the **first two semesters** with one examination at the end of each semester.

#### **5.3 Part III:** Core Subjects, Allied Subjects and Project or Elective Courses:

- 1) Core Subjects: Each programme has a group of core courses arranged semester wise. The syllabi of the core courses will enlighten the students in the acquisition of the basic concepts of their respective disciplines, besides getting focused on to the recent trends. This orientation will amply spur the students towards the vertical mobility in their higher studies. The core courses will span over six semesters and examination shall be conducted in the core subjects at the end of every semester.
- 2) Allied Subjects: In all disciplines the UG students must study two inter departmental courses along with the core courses, which would supplement, suit and support the major course of study, rendering it extensive and significant. The Allied Subjects is to be studied

during the first four semesters of the UG programmes and examination shall be conducted in the end of every semester.

3) Mini project, Project and Elective Courses: In all disciplines the UG student must undergo a Project and he/she must study minimum three Elective Courses and maximum of four courses.

Three elective courses are to be offered one/two in the V semester and one/two in the VI Semester. Elective subjects are to be selected from the list of electives prescribed by the Board of Studies concerned in the fifth and Sixth Semester along with the Core Subjects.

A student shall take up a project work in addition to his elective subjects. The report of the study should be submitted at the end of course of study certified by the supervisor and duly forwarded by the Head of the Department/Principal of the College. The Head of the department of the concerned programme shall assign a project supervisor, who in turn shall assign the topic and monitor the project work of the student.

#### **5.4 Part IV:**

- **1. a)** Those who have not studied Tamil up to XII std and taken a Non-Tamil language under Part-I shall take Tamil Comprising of Two Courses. The course content of which shall be equivalent to that prescribed for the 6 <sup>th</sup> Standard by the Board of Secondary Education and they shall be offered in the third and fourth semesters.
  - **b**) Those who have studied Tamil up to XII std and taken a Non-Tamil language under Part-I shall take Advanced Tamil Comprising of Two Courses in the third and fourth semesters.

(OR)

c) Others that do not come under the above **a+ b categories** can choose the following language comprising of two courses in the third and fourth semesters.

Communicative English

- **2. Ability Enhancement compulsory course I Environmental Studies**: It is a course on environmental science which underlines the importance of environment apart from sensitizing students to the dimensions of environmental problems to be addressed and sorted out, aimed at the global euphoria. The online examination shall be conducted for 50 Marks in the I semester and there is no ESE.
- **3. Ability Enhancement compulsory course II Human Rights:** It is a course to impart theknowledge about the basic human rights, classification of human rights, Basics of Law, Cyber crime and Law. The Online Examination shall be conducted for 50 marks in the II semester and there is no ESE.
- **4. Skill Enhancement Course:** The Elective Courses four in number for each UG Degree programmes from third semester onwards are offered to all students. Four skill based subjects are to be offered one in the III, IV, V and VI Semesters. The examination shall be conducted in the skill based subjects at the end of the semesters where they are offered.

**Note:** The assessment for the category in Part IV -2 and 3 subjects shall be through online examination for the total marks prescribed. There shall be no End Semester examination will be conducted.

**5.5 Part V: Extension Activities:** Every student shall participate compulsorily for period of not less than two years (4 semesters) in any one of the programmes. (NSS/Sports and games/YRC and other extracurricular activities)

Each student must choose any one of the three courses offered during the first four semesters. The object of the slot is to build- up the ethics, awareness and involvement in social service, acquisition of knowledge and training in military discipline leading to national integration and patriotism, and feeling fit and fine through participation in games and athletics.

The student's performance shall be examined by the staff in-charge of extension activities along with the Head of the respective department and a senior member of the Department on the following parameters.

The marks shall be sent to the Controller of Examinations before the commencement of the final semester examinations.

- > 20% of marks for Regularity of attendance
- 60% of marks for Active Participation in classes/camps/games/special
   Camps/programmes in the college/District/ State/ University activities.
- ➤ 10% of marks for Exemplary awards/Certificates/Prizes.
- ➤ 10% of marks for Other Social components such as Blood Donations, Fine Arts, etc.

The grades will be awarded at the end of the Fourth Semester. The mark sheet shall carry the gradation relevant to the marks awarded to the candidates.

This grading shall be incorporated in the mark sheet to be issued at the end of the semester. (Handicapped students who are unable to participate in any of the above activities shall be required to take a test in the theoretical aspects of any one of the above fields and be graded and certified accordingly).

#### **5.6 Part VI:**

#### 1. Additional Credits.

Students are offered the opportunity to undertake Inter department Learning course, and value added courses in addition to their compulsory papers, in order to gain additional credit that would boost their grades. Each department will offer a minimum of 1 paper in thrust area, during 3<sup>rd</sup> and 4<sup>th</sup> semester. A student can choose any one of the paper of his interest in any department. The classes for the inter department learning will be conducted 2 hours per week. Student has to attend the classes. The value added course is offered in I to V semester.

# 7. Requirement to appear for the examinations

- a) A candidate shall be permitted to appear for the End semester examinations for any semester (practical/theory) if
- i) He/she secures **not less than 75%** of attendance in the number of working days during the semester.
- ii) He/she earns a progress certificate from the Head of the institution, of having satisfactorily completed the course of study prescribed in the scheme of examinations for that semester as required by these regulations, and
- iii) His/her conduct has been satisfactory.

Provided that it shall be open to the authority to grant exemption to a candidate who has failed to earn 75% of the attendance prescribed, for valid reasons.

- b) A candidate who has secured **less than 75% but 65%** and above attendance in any semester has to compensate the shortage in attendance in the subsequent semester besides earning the required percentage of attendance in that semester and appear for both semester papers together at the end of the later semester. And the students has to pay single condonation fees.
- c) A candidate who has secured **less than 65% but 50%** and above attendance in any semester shall not be permitted to appear for the current semester papers and the student shall be allowed to appear only for arrear papers.
- d) A candidate who has secured **less than 50%** of attendance are not eligible to attend the regular examinations and to continue the study in the subsequent semester. He/she has to rejoin the semester in which the attendance is less than 50%

#### 8. Restrictions to appear for the examinations

- a) Any candidate having arrear paper(s) shall have to appear in all arrear paper along with the regular semester papers.
- b) "Candidates who fail in any of the course of Part I, II, III, IV & V of UG degree examinations shall complete the course concerned within 5 years from the date of admission to the said programme, and should they fail to do so, they shall take the examination in the texts/ revised syllabus prescribed for the immediate next batch of candidates. If there is no change in the

texts/syllabus they shall appear for the examination in that course with the syllabus in vogue until there is a change in the texts or syllabus. In the event of removal of that course consequent to change of regulation and / or curriculum after 5 year period, the candidates shall have to take up an equivalent course in the revised syllabus as suggested by the Chairman of the concerned board of studies and fulfill the requirements as per the regulation curriculum for the award of the degree.

#### 9. Medium of Instruction and examinations

The medium of instruction and examinations for the courses of Part I shall be the language concerned. For part II, III, IV, V & VI courses the medium of instruction and the medium of examinations is English.

# 10. Submission of Record Note Books for practical examinations

Candidates appearing for practical examinations should submit bonafide Record Note Books prescribed for practical examinations, otherwise the candidates shall not be permitted to appear for the practical examinations.

**12. Passing Minimum**: A candidate who secures **not less than 40% in the** End Semester Examination and 40% marks in the external examination and continuous internal assessment put together in any course of Part I, II, III & IV shall be declared to have passed the examination in the subject (theory or Practical ). Thus the minimum pass mark is 24 out of 60 in ESE and also 40 marks out of 100 (CIA+ESE).

A candidate who passes the examination in all the courses of Part I, II, III, and IV & V shall be declared to have passed, the whole examination. Thus to obtain UG degree a student should pass in all the courses prescribed in the concerned programme. And also he/she should earn 140 credits.

**14. Marks & Grade:** Once the marks of the CIA and end-semester examinations for each of the course are available, they shall be added. The mark thus obtained shall then be converted to the relevant letter grade, grade point as per the details given below and classification to indicate the performance of the candidate.

# 15. Grade Point Average (GPA):

Grade point average (GPA) is calculated for each part taking into account all the courses studied under each part. Calculation of grade point average semester-wise and part-wise is as follows:

Where  $C_i$  = Credit earned for course i in any semester.

Gi= Grade points obtained for course i in any semester.

**16.** Cumulative Grade Point Average (CGPA): For the entire program CGPA is calculated in the following manner.

**17.** Classification of CGPA: A candidate who has passed all the examinations under different parts (Part-I to Part V) is eligible for the following part wise computed final grades based on the range of CGPA.

A candidate who passes all the examinations in Part I to Part V securing following CGPA and Grades shall be declared as follows for Part I or Part II or Part III:

- **a.** A candidate who has passed all the Part-III subjects examination in the first appearance within the prescribed duration of the UG programmes and secured a CGPA of 9 to 10 and equivalent grades "O" or "O+" in part III comprising Core, Electives and Allied subjects shall be placed in the category of "**First Class Exemplary**".
- **b.** A candidate who has passed all the Part-III subjects examination in the first appearance within the prescribed duration of the UG programmes and secured a CGPA of 7.5 to 9 and equivalent grades "D" or "D+" or "D++" in part III comprising Core, Electives and Allied subjects shall be placed in the category of "**First Class with Distinction**".

- **c.** A candidate who has passed all the Part-I or Part-II or Part-III subjects examination of the UG programmes and secured a CGPA of 6 to 7.5 and equivalent grades "A" or "A++" or "A++" shall be declared to have passed that parts in "**First Class**".
- **d.** A candidate who has passed all the Part-I or Part-II or Part-III subjects examination of the UG programmes and secured a CGPA of 5.5 to 6 and equivalent grades "B" or "B+" shall be declared to have passed that parts in "**Second Class**".
- **e.** A candidate who has passed all the Part-I or Part-II or Part-III subjects examination of the UG programmes and secured a CGPA of 4.5 to 5 and equivalent grades "C" or "C+" shall be declared to have passed that parts in "**Third Class**".
- **f.** There shall be no classifications of final results; therefore, award of class for Part IV and Part V, however, those parts shall be awarded with final grades in the end semester statements of marks and in the consolidated statement of marks.
- **18.** Improvement of Marks in the subjects already passed: Candidates desirous of improving the marks awarded in a passed subject in their first attempt shall reappear in the subsequent semester only. The improved marks shall be considered for classification but not for ranking. When there is no improvement, there shall not be any change in the original marks already awarded.
- **19. Conferment of the Degree:** No candidate shall be eligible for conferment of the Degree unless he / she
  - i. Has undergone the prescribed course of study for a period of not less than six semesters and has passed the examinations as have been prescribed therefore.
  - ii. Has completed all the components prescribed under Parts I to Part V in the CBCS pattern to earn 140 credits.
  - iii. Has successfully completed the prescribed Field Work/ Institutional Training (if any) as evidenced by certificate issued by the concerned authorities.

# **20.** Malpractices in Examinations

In case, If a candidate is caught under malpractice, he/she has been restricted to appear for further exams. The candidate Hall Ticket will be seized.

All cases of malpractice by the students in the examinations (ESE and CIA) will be referred by the COE to **Malpractice detection cell**, which has been constituted for the purpose. The Committee will consist of Three Members representing the Faculty of Science, Commerce and humanities / Language, the members will be nominated by the Principal.

The committee will monitor all cases of malpractice and will be taken to Principal's consideration and action will be taken in each case.

**21. Ranking:** A candidate who qualifies for the UG degree course passing all the examinations in the first attempt, within the minimum period prescribed for the course of study from the date of admission to the course and secures I or II class shall be eligible for ranking and such ranking shall be confined to 10 % of the total number of candidates qualified in that particular branch of study, subject to a maximum of 10 ranks. The improved marks shall not be taken into consideration for ranking.

**22. Question Paper Pattern:** The question paper patterns shall be followed for CBCS pattern syllabifor the candidates admitted from the academic year 2017-18 are provided **in syllabi itself.**

- **23. Syllabus:** The syllabus for various courses shall be clearly demarcated into five viable units in each paper/subject.
- **24. Revision of Regulations and Curriculum:** The above Regulation and Scheme of Examinations shall be in vogue without any change for a minimum period of three years from the date of approval. The college may revise /amend/ change the Regulations and Scheme of Examinations, if found necessary.
- 25. Provision for Appeal: There shall be a provision for Appeal for a candidate who may be dissatisfied with the Grade he/she has been awarded. He/she can approach the Grievance Cell with the written submission together with all facts, the assignments, and test papers etc, which were evaluated. He/she can do so before the commencement of end semester examination. The Grievance Cell is empowered to revise the grades if the case is genuine and is also empowered to penalize the candidate if his/her submission is found to be baseless and unduly motivated. The composition of the grievance cell is as follows.
- 1. The Principal
- 2. One senior faculty member (other than those concerned with the evaluation of the course concerned).
- 3. One senior faculty members / subject experts.
- **26. Re-Totaling:** Candidates of all courses are eligible to apply for Re-totalling of their marks. Application forms can be obtained from the Controller of Examination Section along with a request letter. The filled application should be submitted to the Controller of Examination Section along with Photo copy of their mark sheets with the prescribed fees within one week. The Re-totalling result will be sent to the concerned Head of the Departments within 15days.

#### 27. Re-Valuation

Original Mark Statement should not be enclosed. Enclose the photo copy of the Internet Result along with the application. Requisition for revaluation must reach the Controller of Examinations within 7 DAYS from the date of publication of results. There is no provision for revaluation of practical examination. Papers Incomplete / defective application will be rejected

and the revaluation fee will not be refunded. The application duly filled in should be submitted to the Controller of Examinations only through the Principal. Re-valuation of result will be sent to the concerned Head of the Department.

# 28. Photocopy of the Valued Answer Scripts

Students of all UG Programmes are permitted to obtain their Xerox copy of valued answer papers where single valuation is adopted. The filled application should be submitted to the Controller of Examination Section along with Photo copy of their mark sheets within one week. Students should apply either for revaluation or photocopy of the answer script.

**29. Supplementary Exam:** Supplementary examination will be conducted after the VI semester for the students who have failed in only one subject.

- **1. PG Curriculum**: The PG Curriculum under the CBCS consist only part III and the medium of instruction is English. Part six provides additional credits with Value added courses and Advanced Learners Courses.
- **2.** Eligibility for Admission to the Course: Candidate for admission to the first year of the PG degree programme shall be required to **have passed the UG Degree** from recognized University/University affiliated college/Autonomous college.
- **3. Duration of the Programme:** The PG programme will comprise four semesters with two semesters per academic year, extending over a total duration of two years. Examination shall be conducted at the end of every semester for the respective subjects. Each semester has 90 instructional days consists of 5 teaching hours per working day. Thus, each semester has 450 teaching hours and the whole programme has 1800 teaching hours.

**4. Choice Based Credit System (CBCS):** All post graduate Programmes offered by the University shall be under Choice Based Credit System (CBCS). Choice based credit system is introduced with the aim of offering flexibility in the choice of courses to the students.

- To assess the Performance of students in terms of marks & Credit points
- **5.** Course of Study: The course of study for the PG degree courses of all branches shall consist of the following
- **5.1 Part III:** Core Subjects, Allied Subjects and Project or Elective Courses:
  - 1) Core Subjects: Each programme has a group of core courses arranged semester wise. The syllabi of the core courses will enlighten the students in the acquisition of the basic concepts of their respective disciplines, besides getting focused on to the recent trends. This orientation will amply spur the students towards the vertical mobility in their higher studies.

The core courses will span over four semesters and examination shall be conducted in the core subjects at the end of every semester.

2) Mini project, Project and Elective Courses: In all disciplines the PG student must undergo a Project and he/she must study minimum three Elective Courses and maximum 4 Elective courses (For MBA – minimum 8 Elective courses).

Three elective courses are to be offered one/two in the II semester and one/two in the III & IV Semesters. Elective subjects are to be selected from the list of electives prescribed by the Board of Studies concerned in the second, third and fourth Semester along with the Core Subjects.

A student shall take up a project work in addition to his elective subjects. The report of the study should be submitted at the end of course of study certified by the supervisor and duly forwarded by the Head of the Department/Principal of the College. The Head of the department of the concerned programme shall assign a project supervisor, who in turn shall assign the topic and monitor the project work of the student.

#### 6. Scheme of examination

#### 7. Requirement to appear for the examinations

- a) A candidate shall be permitted to appear for the End semester examinations for any semester (practical/theory) if
- i) He/she secures **not less than 75%** of attendance in the number of working days during the semester.
- ii) He/she earns a progress certificate from the Head of the institution, of having satisfactorily completed the course of study prescribed in the scheme of examinations for that semester as required by these regulations, and
- iii) His/her conduct has been satisfactory.

Provided that it shall be open to the authority to grant exemption to a candidate who has failed to earn 75% of the attendance prescribed, for valid reasons.

- b) A candidate who has secured **less than 75% but 65%** and above attendance in any semester has to compensate the shortage in attendance in the subsequent semester besides earning the required percentage of attendance in that semester and appear for both semester papers together at the end of the later semester. And the students has to pay single condonation fees.
- c) A candidate who has secured **less than 65% but 50%** and above attendance in any semester shall not be permitted to appear for the current semester papers and the student shall be allowed to appear only for arrear papers.
- d) A candidate who has secured **less than 50%** of attendance are not eligible to attend the regular examinations and to continue the study in the subsequent semester. He/she has to rejoin the semester in which the attendance is less than 50%

#### 8. Restrictions to appear for the examinations

a) Any candidate having arrear paper(s) shall have to appear in all arrear paper along with the regular semester papers.

b) "Candidates who fail in any of the course of Part III of PG degree examinations shall complete the course concerned within 4 years from the date of admission to the said programme, and should they fail to do so, they shall take the examination in the texts / revised syllabus prescribed for the immediate next batch of candidates. If there is no change in the texts/syllabus they shall appear for the examination in that course with the syllabus in vogue until there is a change in the texts or syllabus. In the event of removal of that course consequent to change of regulation and / or curriculum after 4 year period, the candidates shall have to take up an equivalent course in the revised syllabus as suggested by the Chairman of the concerned board of studies and fulfill the requirements as per the regulation curriculum for the award of the degree.

#### 9. Medium of Instruction and examinations

The medium of instruction and examinations for the courses of Part III courses is English.

# 10. Submission of Record Note Books for practical examinations

Candidates appearing for practical examinations should submit bonafide Record Note Books prescribed for practical examinations, otherwise the candidates shall not be permitted to appear for the practical examinations.

**12. Passing Minimum**: A candidate who secures **not less than 50% in the** End Semester Examination and 50% marks in the external examination and continuous internal assessment put together in any course of Part III shall be declared to have passed the examination in the subject (theory or Practical). Thus the minimum pass mark is 30 out of 60 in ESE and also 50 marks out of 100 (CIA+ESE).

A candidate who passes the examination in all the courses of Part III shall be declared to have passed, the whole examination. Thus to obtain PG degree a student should pass in all the courses prescribed in the concerned programme. And also he/she should earn 100 credits for MBA / 90 credits for all other PG courses.

**13. Marks & Grade:** Once the marks of the CIA and end-semester examinations for each of the course are available, they shall be added. The mark thus obtained shall then be converted to the relevant letter grade, grade point as per the details given below and classification to indicate the performance of the candidate.

# 14. Grade Point Average (GPA):

Grade point average (GPA) is calculated for each part taking into account all the courses studied under each part. Calculation of grade point average semester-wise and part-wise is as follows:

**15.** Cumulative Grade Point Average (CGPA): For the entire program CGPA is calculated in the following manner.

A candidate who passes all the examinations in Part III securing following CGPA and Grades shall be declared as follows **for Part III**:

- **g.** A candidate who has passed all the Part-III subjects examination in the first appearance within the prescribed duration of the UG programmes and secured a CGPA of 9 to 10 and equivalent grades "O" or "O+" in part III comprising Core, Electives and Allied subjects shall be placed in the category of "**First Class Exemplary**".
- **h.** A candidate who has passed all the Part-III subjects examination in the first appearance within the prescribed duration of the PG programmes and secured a CGPA of 7.5 to 9

and equivalent grades "D" or "D+" or "D++" in part III comprising Core, Electives and Allied subjects shall be placed in the category of "**First Class with Distinction**".

- i. A candidate who has passed all the Part-III subjects examination of the PG programmes and secured a CGPA of 6 to 7.5 and equivalent grades "A" or "A+" or "A++" shall be declared to have passed that parts in "First Class".
- **j.** A candidate who has passed all the Part-III subjects examination of the PG programmes and secured a CGPA of 5.5 to 6 and equivalent grades "B" or "B+" shall be declared to have passed that parts in "Second Class".
- 17. Improvement of Marks in the subjects already passed: Candidates desirous of improving the marks awarded in a passed subject in their first attempt shall reappear in the subsequent semester only. The improved marks shall be considered for classification but not for ranking. When there is no improvement, there shall not be any change in the original marks already awarded.
- **18. Conferment of the Degree:** No candidate shall be eligible for conferment of the Degree unless he / she
  - i. Has undergone the prescribed course of study for a period of not less than four semesters and has passed the examinations as have been prescribed therefore.
  - ii. Has completed all the components prescribed under Parts III in the CBCS pattern to earn 90/100 credits.
  - iii. Has successfully completed the prescribed Field Work/ Institutional Training (if any) as evidenced by certificate issued by the concerned authorities.

# 19. Malpractices in Examinations

In case, If a candidate is caught under malpractice, he/she has been restricted to appear for further exams. The candidate Hall Ticket will be seized.

All cases of malpractice by the students in the examinations (ESE and CIA) will be referred by the COE to **Malpractice detection cell,** which has been constituted for the purpose. The Committee will consist of Three Members representing the Faculty of Science, Commerce and humanities / Language, the members will be nominated by the Principal.

The committee will monitor all cases of malpractice and will be taken to Principal's consideration and action will be taken in each case.

- **20. Ranking:** A candidate who qualifies for the PG degree course passing all the examinations in the first attempt, within the minimum period prescribed for the course of study from the date of admission to the course and secures I or II class shall be eligible for ranking and such ranking shall be confined to 10 % of the total number of candidates qualified in that particular branch of study, subject to a maximum of 10 ranks. The improved marks shall not be taken into consideration for ranking.
- **21. Question Paper Pattern:** The question paper patterns shall be followed for CBCS pattern syllabi for the candidates admitted from the academic year 2017-18 are provided **in syllabi itself.**

The following question paper patterns will be followed for the PG candidates.

- **22. Syllabus:** The syllabus for various courses shall be clearly demarcated into five viable units in each paper/subject.
- **23. Revision of Regulations and Curriculum:** The above Regulation and Scheme of Examinations shall be in vogue without any change for a minimum period of three years from the date of approval. The college may revise /amend/ change the Regulations and Scheme of Examinations, if found necessary.
- **24**. **Provision for Appeal**: There shall be a provision for Appeal for a candidate who may be dissatisfied with the Grade he/she has been awarded. He/she can approach the Grievance Cell

with the written submission together with all facts, the assignments, and test papers etc, which were evaluated. He/she can do so before the commencement of end semester examination. The Grievance Cell is empowered to revise the grades if the case is genuine and is also empowered to penalize the candidate if his/her submission is found to be baseless and unduly motivated. The composition of the grievance cell is as follows.

- 1. The Principal
- 2. One senior faculty member (other than those concerned with the evaluation of the course concerned).
- 3. One senior faculty members / subject experts.

**25. Re-Totalling:** Candidates of all courses are eligible to apply for Re-totalling of their marks. Application forms can be obtained from the Controller of Examination Section along with a request letter. The filled application should be submitted to the Controller of Examination Section along with Photo copy of their mark sheets with the prescribed fees within one week. The Re-totalling result will be sent to the concerned Head of the Departments within 15days.

#### 26. Re-Valuation

Original Mark Statement should not be enclosed. Enclose the photo copy of the Internet Result along with the application. Requisition for revaluation must reach the Controller of Examinations within 7 DAYS from the date of publication of results. There is no provision for revaluation of practical examination. Papers Incomplete / defective application will be rejected and the revaluation fee will not be refunded. The application duly filled in should be submitted to the Controller of Examinations only through the Principal. Re-valuation of result will be sent to the concerned Head of the Department.

# 27. Photocopy of the Valued Answer Scripts

Students of all PG Programmes are permitted to obtain their Xerox copy of valued answer papers where single valuation is adopted. The filled application should be submitted to the Controller of Examination Section along with Photo copy of their mark sheets within one week. Students should apply either for revaluation or photocopy of the answer script.

**28. Supplementary Exam:** Supplementary examination will be conducted after the IV semester for the students who have failed in only one subject.
