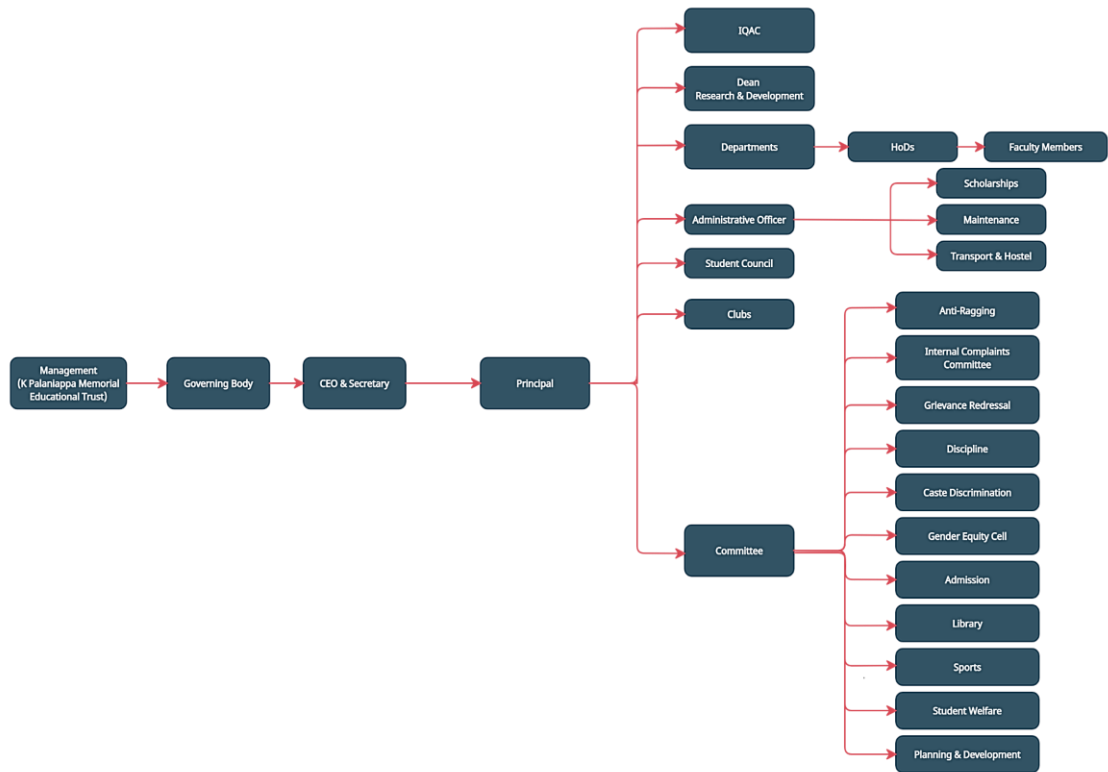

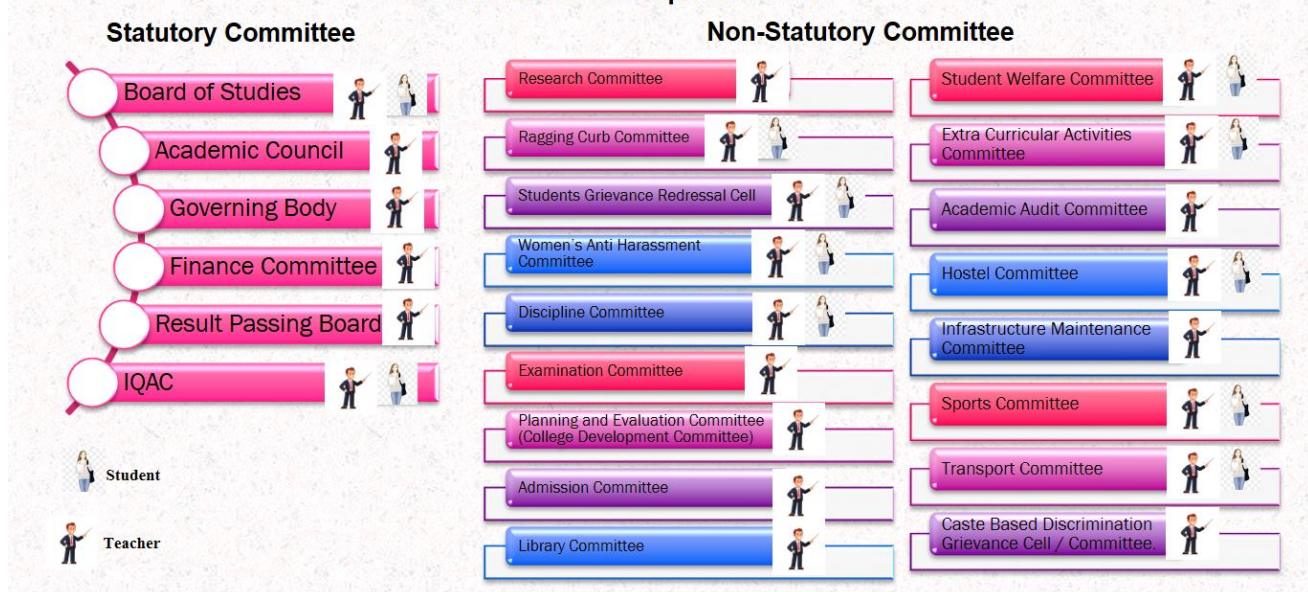
• **Organizational chart and processes**
